# Gary Johnson for President



## **Immigration:**

America is a land of immigrants. Legal immigration should focus on making it easier and simpler for willing workers to come here with a temporary work visa, pay taxes, contribute to society, and fill jobs as the market demands.

As the former governor of a southern border state, I know fences and walls do not keep out illegal immigrants. Real border security means knowing who is coming here and why.

With workable employer verification systems, smarter border enforcement, and common sense, a national problem can be turned into a national benefit.

## **Foreign Policy:**

Maintaining a strong national defense is the most basic of the federal government's responsibilities. However, building schools, roads, and hospitals in other countries are not among those basic obligations. Yet that is exactly what we have been doing for much of the past 10 years.

Given trillion-dollar deficits, America simply cannot afford to be engaged in foreign policy programs that are not clearly protecting U.S. interests. There is nation-building and rebuilding to be done right here at home.

Our military should remain the most potent force for good on Earth. To do this, we should resort to military action as the last option and only as provided in the Constitution.

## **Internet and Technology:**

It is not a coincidence that the one element of our modern economy that has been uniquely left free of government interference has created equally unique growth and transformation. An Internet free of regulation and taxation has produced innovation and enhancements to quality of life almost unparalleled in human history. If the market demands Internet services, speed and access, the market will provide them without any help from the government. The government, with its regulatory foot in the door, will inevitably end up attempting to regulate and referee content, speech, and commerce.

## **Civil Liberties:**

Civil liberties are so foundational to America that the first eight amendments to the Constitution address them directly. These amendments enshrine government's duty to protect individual liberties, including the rights to free speech and free association.

But today, government has created for itself sweeping powers to monitor the private lives of individuals and otherwise intrude upon our daily activities, our households and our businesses. The extent of the government's reach today would be unrecognizable to the Founders.

Much of the recent erosion in civil liberties has occurred in the name of national security. But we can – and must -- combat threats to our safety while adhering to due process and the rule of law.

## **The Economy and Taxes:**

Americans are more concerned than ever before about the future of our economy, and those concerns are well-founded. As a nation, we simply can't afford to continue borrowing 43 cents out of every dollar we spend. Balancing the budget will mean making some serious changes in Washington, but these will be the corrections America needs to remain a free, prosperous, and secure nation.

## **Education and School Choice:**

American education is at a crossroads.

We can either choose to continue down the path of higher costs, poorer results, and top-down thinking, or challenge the status quo by using what actually works rather than what we wish would work.

The problem is public education in America is now doing less with more. This is unsustainable for our pocketbooks and, most importantly, unfair to our children.

Now, imagine an educational system that not only educates students better, but also does it for less money every year. It would give each American child the opportunity to choose an individualized education to realize his or her dreams.

## **Drug Policy Reform:**

Despite our best efforts at enforcement, education and interdiction, people continue to use and abuse illegal drugs.

The parallels between drug policy today and Prohibition in the 1920's are obvious, as are the lessons our nation learned. Prohibition was repealed because it made matters worse. Today, no one is trying to sell our kids bathtub gin in the schoolyard and micro-breweries aren't protecting their turf with machine guns. It's time to apply that thinking to marijuana. By making it a legal, regulated product, availability can be restricted, under-age use curtailed, enforcement/court/incarceration costs reduced, and the profit removed from a massive underground and criminal economy.

By managing marijuana like alcohol and tobacco – regulating, taxing and enforcing its lawful use – America will be better off. The billions saved on marijuana interdiction, along with the billions captured as legal revenue, can be redirected against the individuals committing real crimes against society.

## **Spending and the Deficit:**

Government spends too much because it does too much. Unchecked deficits are the single greatest threat to our national security. Unless we take significant steps soon, our federal debt will equal the entire economic production of the United States.

We must fundamentally reassess the role of the federal government, always asking the question: Should the government be doing this in the first place? That reassessment should begin with the President submitting a truly balanced budget in 2013.

# Changing the Party from Within: Ron Paul, Gary Johnson, and Libertarianism

Ron Paul's biggest supporters have made their intentions clear: Changing the Republican Party from within surpasses any devotion they may have for the Libertarian Party and its presidential candidate, Gary Johnson.

Still, Johnson and the Libertarian Party are hoping to draw support from Paul's devotees, assuming the Texas congressman fails to snag the GOP nod from former Massachusetts Gov. Mitt Romney.

Both Paul and Johnson have very similar fiscally conservative and socially live-and-let-live ideals. They both want smaller government, lower taxes, looser business regulations, and to abolish the Federal Reserve, as well as allow gay unions and legalize marijuana. There are some small differences; both were against going into Iraq and Afghanistan, but Johnson supports some military interventions for humanitarian reasons and Paul doesn't. Ron Paul is against abortions, while Johnson supports abortion rights.

The biggest difference between the two is not policy, but the path they've chosen. The presence of both of them in the presidential race – particularly Paul – indicates how libertarians may have more influence in the Republican Party's platform this year at the national convention than they ever have before.

For Johnson, running for president is also more about voice than winning. "When [Johnson] was running in the Republican Party, he was largely excluded from the debates," his campaign spokesman Joe Hunter said. "It was a crowded field ... Frankly, the [third-party] strategy is proving to be correct. He's got a much more effective microphone than he did in the Republican field."

Another great microphone? The support of enthusiastic, strategizing Paulites.

Libertarian Party Executive Director Carla Howell said she expects the "vast majority" of Ron Paul supporters to vote for Johnson if Paul doesn't make the ticket come November. "Gov. Johnson and much of the Libertarian party wish Dr. Paul every success in his pursuit of the GOP nomination. We welcome his supporters with open arms," she said.

But that doesn't mean Paul himself will endorse the candidate (although Howell said she'd love that) nor that Paul's loyal fans will turn into Johnsonites once the national convention concludes and Paul doesn't make the ticket.

Howell said she regularly talks to Paul campaign staff but there has been no talk about an endorsement (Paul dodged a question on Bloomberg TV last week about whether or not he would endorse Romney, saying it depends on how the platform ends up), while Hunter said there has been no coordination between the two campaigns.

Harmon said he personally had no idea who he would vote for in November assuming Paul was not on the ticket, but could see himself picking Johnson as a "protest vote." "I'd rather throw my vote away than throw my country away," said Harmon, who clarified he was speaking on behalf of himself and not Endorse Liberty.

Still, that doesn't necessarily mean there should be hard feelings between the two candidates. In fact, just the opposite. Even if Johnson is barely riding the coattails of Paul's campaign, two libertarian candidates in an election just shows how much the movement is creeping its way into mainstream Republican politics.

"Ron Paul has clearly chosen to stay with the GOP, so we're not working directly together, but we recognize that we are all working together for the broader cause of liberty," Howell said.

A lot of Paulites agree.

"Many people, including myself, were in awe to see, not just one, but TWO Libertarians running for president this year in the Republican Party," wrote Tyler Mittan, who has a blog called The Angry Libertarian. "This is the Libertarian's chance to really get their message across."

# The Party Isn't Over
